### **Detailed Narrative:**

Inspection took place with Ina Chomyshyn – Occupational Hygienist with the Ministry of Labour Training and Skills Development.

The workplace parties indicated they have measures and procedures in place addressing the following:

#### Information & Instruction to Workers:

Posters and instruction posted at the workplace. Information is available to workers regarding Covid.

#### Health and Safety Representative

There are two Health and Safety Representatives who are workers for the workplace. Monthly inspections are taking place. Representatives have Health and Safety training.

### Social/Physical Distancing Measures in Place:

Where workers are unable to physical distance there are masks available for use. There are barriers in place at reception. Masks are used when working with customers.

### Screening Measures:

Active screening is taking place. Workers are having their temperature taken and told to stay home if sick. They are not to return to work until they have cleared a Covid test or self isolated for 14 days. There are 2 pharmacists who are attending at Long Term Care homes and speaking with staff. They are tested for Covid twice a month and use source control masking when speaking to staff. The staff they are conferencing with all have masks on.

### Cleaning and Disinfecting:

Cleaning/disinfecting takes place between uses of equipment and at the reception location between customers. Employer has re-enforced the instruction to workers regarding physical distancing and PPE (masks/gloves)..

I attended this workplace with health and safety inspector James Gionet. I spoke with the owner and observed workplace conditions, facilities and work tasks. We discussed the following topics:

  - ensure that workers use respirators in accordance with the regulation [O. Reg. 833 clause 9 (1)(c)]
  - ensure that respirators are cared for and maintained in accordance with the manufacturer's instructions

[O. Reg. 833 section 13]

Workers who use respirators users must:

- be trained in care and use
- follow the manufacturer's instructions
- be fit tested (for tight-fitting respirators)
- perform user seal checks every time a tight-fitting respirator is used
- be clean shaven (for tight-fitting respirators)

Respirators must be NIOSH approved or equivalent. [NIOSH = USA National Institute for Occupational Safety and Health]

CSA Standard 94.4-as updated "Selection, Use and Care of Respirators" outlines the components and implementation of an effective respiratory protection program.
